KAUPAPA

The Ngāti Whakaue Whakanuia 2015 has a “Whānau Fun Day” kaupapa. To connect the people with the land from which the settlement funds come.

Tak Mutu (a Ngāti Whakaue mountain biking entrepreneur and owner of Multi-Day Adventures) has made available his resources for the day to take 60 Ngāti Whakaue members on a guided mountain-biking tour of Whakarewarewa Forest, at no cost to the riders.

HOW IT WORKS

Because numbers are limited, each marae may allocate/nominate 10 members to participate in the guided tour.

You will need to:

- Meet 30 mins before the start time at Waipa Mountain Bike Carpark, Waipa Mill Road
- Bring their own bikes or you can use the bikes onsite if you arrange this in advance.
